

### Administrative (3)

- COVID-19 Budget Impacts
- Major revenue accounts are down a total of \$497,492 YTD thru November from the same period in 2019.
- Local Coronavirus Relief Fund (213) (CARES Act funds) received approximately \$280,000
- Governor DeWine has proposed up to \$1.5 billion to Ohio Employers this fall. BWC's board of directors will vote on this proposal September 25. This proposed dividend equals approximately 100% of the premiums employers paid in policy year 2019. This would amount to be roughly \$85,000 to Sheffield Village. OBWC has also announced a 10% reduction in the 2021 premium. Also proposed was an additional 5 billion dollar rebate which we should receive in December which will amount to another \$330,000. This rebate has not yet been received.
- RITA news alert: "On July 2, 2020 the Buckeye Institute has filed a lawsuit against both the City of Columbus and the State of Ohio claiming that
  the state law allowing municipalities to continue to collect municipal income tax from employees working from home during the Governor's
  declaration of emergency was unconstitutional. We will keep our members apprised as this litigation progresses." NO NEW UPDATES
  REGARDING THIS LAWSUIT as of 12.10.2020. RITA is still working on estimating the impact this could have to the Village.
