DRAFT ORDINANCE NO. 2740

AN ORDINANCE TO INCREASE APPROPRIATIONS FOR CAPITAL OUTLAY IN THE SEWER FUND OF THE VILLAGE OF SHEFFIELD FOR FY2020 AND DECLARING AN EMERGENCY.

WHEREAS, it becomes necessary to amend appropriations to meet expenditures within the various funds and departments listed below.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF SHEFFIELD, IN THE COUNTY OF LORAIN, AND THE STATE OF OHIO:

<u>Section 1</u>. That the appropriations in the following funds be amended as follows:

<u>Section 2</u>. That it is found and determined that formal actions of this council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberation of this Council that resulted in such formal action occurred in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. That this Ordinance be, and hereby is declared to be an emergency measure, the emergency being the immediate necessity to provide adequate money for the public health, peace and welfare of the Village of Sheffield, Ohio, appropriating money to existing funds for the 2020 appropriations. Wherefore this Ordinance shall be in force and effect from and upon its adoption and approval.
